WHO Global Code of Practice on the International Recruitment of Health Personnel

Background

The WHO Global Code of Practice on the International Recruitment of Health Personnel (“the Code”) was adopted in 2010 at the 63rd World Health Assembly (WHA Res 63.16). The Code seeks to strengthen the understanding and ethical management of international health personnel recruitment and migration through strengthening data, information, and international cooperation.

The WHO Director General is mandated to report on implementation of the WHO Global Code to the World Health Assembly every 3 years. Article 9.4, additionally provides that the WHO Secretariat may consider reports from relevant stakeholders on activities related to implementation of the WHO Global Code. During the 2nd Round of National Reporting, seventy-four countries submitted complete national reports: an increase in over 30% from the first round, with improvement in the quality and the geographic diversity of reporting. The 2nd Round of National Reporting also saw the launch of an Independent Stakeholder Reporting Instrument.

In parallel with the 3rd Round of National Reporting for Member States, an Independent Stakeholders Reporting instrument is made available to facilitate stakeholders reporting. This additional module facilitates contribution from all relevant stakeholders, as identified in article 9.4, to enrich knowledge on the Code’s implementation. As described in the article 2.2, stakeholders “such as **health personnel, recruiters, employers, health-professional organizations, relevant subregional, regional and global organizations**, whether **public or private sector**, including **nongovernmental**, and **all persons concerned with the international recruitment of health personnel**” are welcomed and encouraged to participate.
