



Burkina Faso

GENERAL INFORMATION

Burkina Faso is a country with an approximate area of 274 thousand square kilometers (UNO, 2008). The population is 16,286,706 and the sex ratio (men per hundred women) is 99 (UNO, 2009). The proportion of the population under the age of 18 years is 51% and the proportion above age 60 is 2% (UNO, 2009). The literacy rate is 47% for men and 33% for women (UN Statistics, 2008). The life expectancy at birth is 53 years for males and 55 years for females (UNO, 2005-2010). The healthy life expectancy at birth is 42 years for males and 55 years for females (UNPD, 2010). The country is in the low income group (based on 2010 World Bank criteria). The total expenditure on health as a percentage of gross domestic product is 6.37% and the per capita government expenditure on health (PPP int. \$) is \$41.0 (WHO, 2006). Suicide rate information is not available. In Burkina Faso, neuropsychiatric disorders are estimated to contribute to 5.8% of the global burden of disease (WHO, 2008).

GOVERNANCE

An officially approved mental health policy does not exist and mental health is not specifically mentioned in the general health policy.

A mental health plan does not exist.

Dedicated mental health legislation does not exist. However, legal provisions concerning mental health are covered in other laws (e.g. welfare, disability, general health legislation etc.).

FINANCING

Mental health and mental hospital expenditures by the government health department/ministry are not available.

MENTAL HEALTH CARE DELIVERY

Primary Care

Prescription regulations authorize primary health care doctors to prescribe and/or to continue prescription of psychotherapeutic medicines. The department of health also permits primary health care nurses to prescribe and/or to continue prescription of psychotherapeutic medicines. However, official policy does not permit primary health care nurses to independently diagnose and treat mental disorders within the primary care system.

The majority of primary health care doctors and nurses have not received official in-service training on mental health within the last five years. Officially approved manuals on the management and treatment of mental disorders are not available in the majority of primary health care clinics. Official referral procedures for referring persons from primary care to secondary/tertiary care exist, as do referral procedures from tertiary/secondary care to primary care.
