Saint Vincent and the Grenadines

GENERAL INFORMATION

Saint Vincent and the Grenadines is a country with an approximate area of 0 thousand square kilometers (UNO, 2008). The population is 109,284 and the sex ratio (men per hundred women) is 102 (UNO, 2009). The proportion of the population under the age of 18 years is 33% and the proportion above age 60 is 7% (UNO, 2009). The life expectancy at birth is 70 years for males and 74 years for females (UNO, 2005-2010). The healthy life expectancy at birth is 60 years for males and 74 years for females (UNPD, 2010). The country is in the Upper Middle income group (based on 2010 World Bank criteria). The total expenditure on health as a percentage of gross domestic product is 5.65% and the per capita government expenditure on health (PPP int. \$) is \$245.0 (WHO, 2006). The suicide rate for males is 7.3 per 100,000 population and for females is 0.0 per 100,000 population. In Saint Vincent and the Grenadines, neuropsychiatric disorders are estimated to contribute to 18.1% of the global burden of disease (WHO, 2008).

GOVERNANCE

An officially approved mental health policy doesn't exist. Mental health is not specifically mentioned in the general health policy.

A mental health plan doesn't exist.

Dedicated mental health legislation exists and it was initiated or most recently revised in 1991. Legal provisions concerning mental health are not covered in other laws (e.g., welfare, disability, general health legislation etc.).

FINANCING

Mental health expenditures by the government health department/ministry are 5.6% of the total health budget. Mental hospital expenditures are 100.0% of the total mental health budget.

MENTAL HEALTH CARE DELIVERY

Primary Care

Prescription regulations authorize primary health care doctors to prescribe and/or to continue prescription of psychotherapeutic medicines. The department of health does not authorize primary health care nurses to prescribe and/or to continue prescription of psychotherapeutic medicines.

It is unknown whether the majority of primary health care doctors have received official in-service training on mental health within the last five years. It is also unknown whether official referral procedures for referring persons from primary care to secondary/tertiary care or from tertiary/secondary care to primary care exist.
