# **CALL FOR PROPOSAL**

Contractual Partner to support the Viral Hepatitis (VH) Estimates Capacity Building and Development of VH Estimation Training Materials and Manual of Procedures (MOP)



## 1. Summary

The World Health Organization (WHO) Philippines is looking for an institutional contractual partner to support the Viral Hepatitis (VH) Estimates capacity building and development of VH Estimation training materials and Manual of Procedures (MOP) under an Agreement for Performance of Work (APW) contract.

The proposals are due by 20 March 2023.

## 2. Background

An estimated 7.3 million adult Filipinos are chronically infected with the Hepatitis B virus (HBV). In the Philippines, chronic Hepatitis B infection (CHB) is the leading cause of cirrhosis and hepatocellular carcinoma (HCC). Hepatocellular carcinoma is the second most common cause of cancer-related deaths in the country. Committed to the strategic framework of Philippine Development Plan 2023-2028 and elimination of viral hepatitis as public threats of Global Health Sector Strategies on HIV, Viral Hepatitis, Sexually Transmitted Infections (STI) for the period of 2020-2030 the Philippines' Department of Health strengthen the Policies on the Prevention and Control of Viral Hepatitis through the Cancer Control Division Program. Such elimination programmes can only be implemented under the guidance of strategic information. To ensure the sustainability of Viral Hepatitis Estimates validation activity through capacity building and development of training materials and manual of operations.

## 3. Timeline

### 5. Scope of Work

In close collaboration with the Department of Health (DOH) – Epidemiology Bureau (EB) and guidance of the WHO Country Office Philippines, the contractual partner shall deliver the following items:

- I. Prepare a specific work plan and timetable for the activities related to it.
- II. Conduct a pre-training baseline assessment such as but not limited to desk review for the training design, participate, and document the key assumptions in the CDAF PRoGReSs Model Training.
- III. Develop training materials and a manual of procedures and facilitate/conduct training.

## 6. Completion of Work

The work to be done under this contract shall be Contractual Partner to support the Viral Hepatitis (VH) Estimates Capacity Building and Development of VH Estimation Training Materials and Manual of Procedures (MOP) as set out in the Terms of Reference. The contract shall be completed in not more than 2 months from the commencement of the Work, or otherwise as agreed in writing among the Owner and the Contractor. The work shall be done in strict compliance with the Contract, Specifications, Schedules, and all other Contract documents and all Instructions. Failure to do so shall be at the Contractor's risk and account. Submission of Bid by the Contractor shall constitute acknowledgement by the Contractor that it is aware of and concurs with all the requirements or conditions incorporated in the Call for Proposal and the other documents.

As time is an essential element of this Contract, for failure to complete all work within the stipulated as set out in the Terms of Reference, the Owner shall charge the Contractor liquidated damages. This shall be in the amount the sum of 0.5% of the total contract amount per day (Saturdays, Sundays and holidays are included) but not to exceed on total 10% (ten percent) of the contract amount. These liquidated damages shall be for the added cost incurred by the Owner for such delay and also for the inconvenience caused to the users of the Work. It is understood that this is not a penalty but a fixed sum representing the liquidated damages for each calendar day of the delay. Delay shall be counted from the agreed completion date, considering further time extensions approved by the Owner, to the date of completion of work.

The contractual partner or institution's members must fulfill the following educational qualifications and work experience:

- Essential: University degree in public health, epidemiology, or other related fields
- Desirable: University degree in medicine; Postgraduate degree in medicine, public health, epidemiology, or other related fields

  - At least five years of experience related to the scope of work, specifically those related to viral hepatitis initiatives for disease incidence, prevalence projection, and disease modeling

#### Desirable:

- Relevant experience with collaborating government agencies, particularly coordination with DOH Epidemiology Bureau; strong ability to work in a multisectoral environment with diverse stakeholders
- Experience in producing concise reports and presentations, training modules, and materials
- Extensive experience in conducting training and facilitation sessions

- Sound knowledge in producing concise reports and presentations, training modules, and materials
- Sound knowledge in conducting training and facilitation sessions
- Ability to work harmoniously as a member of a team, adapt to diverse educational and cultural backgrounds, and maintain a high standard of personal conduct
