CALL FOR PROPOSALS

Technical Assistance on Development of Local Investment Planning for Health (LIPH) Handbook



1. Summary

The World Health Organization (WHO) Philippines is searching for an institutional partner to develop an updated comprehensive, responsive and user-friendly LIPH Handbook that is aligned with the Universal Health Care Act and current LIPH issuances and directions.

The proposals are due by 12 March 2021.

Background

Development of the Local Investment Plan for Health (LIPH), the three-year medium term plan, prepared by Provinces, Highly Urbanized Cities (HUCs) and Independent Component Cities (ICCs), and its yearly interpretation in the Annual Operational Plans (AOP), was initiated in 2005. These plans have since been institutionalized as the localization tools of national health programs, bases for resource mobilization, technical assistance provision and allocation. The LIPH is a key mechanism to facilitate alignment of plans of Province/HUCs/ICCs with national priorities and thrusts. It contains strategies and directions to support the overall attainment of goals of better health outcomes, more responsive health system, and more equitable healthcare financing at the local level.

In 2015, the Bureau of Local Health Systems Development, in consultation with regional health staff and local health officers, came up with the LIPH handbook. The handbook served as a consolidated guide for Provinces/HUCs/ICCs Health Offices in the development of LIPHs and AOPs, and for regional health staff in the provision of technical assistance to LGUs. However, due to emergence of new health reforms since then, guidelines and directions in the handbook needed to be constantly updated through policy issuances.

With the passage of the Universal Heath Care (UHC) Act (RA 11223) and its Implementing Rules and Regulations (IRR) in 2019, the significance of LIPH and AOPs is highlighted. Section 22 of the UHC Act states that "the national government, though the DOH, shall provide financial and non-financial matching grants ... in accordance with the approved province-wide and city-wide health investment plans."

The said provision requires that the LIPH/AOP development process be improved to produce better LGU plans with timely submission so that DOH are able to use these as reference for technical assistance/grants. Two Administrative Orders on LIPH/AOP, AO 2020-0022, Guidelines on the Development of Local Investment Plans for Health and AO 2020-0018 Guidelines on Contracting with Provice/City-wide Health Systems were also issued in support of the UHC.

In light of the above, there is an urgent need to update the LIPH handbook to guide the LGUs and regional health staff in these revised processes, in tiem for the crafting of 2023-2025 LIPH.

Purpose

This APW is aimed to review the 2015 LIPH Handbook nad all issuances related to LIPH; to determine the demands and requirements of UHC for LIPH/AOP; and to develop a

comprehensive, responsive and user-friendly LIPH Handbook covering among others: plan development, implementation, monitoring and evaluation.

2. Timeline

The implementation timeline for the project is from 22 March 2021 to 22 June 2021.

Deliverable 2.1 Report on the KII/FGD/consultation activities conducted

Output 3. Develop/update the LIPH Handbook based on the results/outputs of 1-2; print the final LIPH Handbooks for dissemination

Deliverable 4.2: Electronic copies of all deliverables

- High degree of familiarity on issues on national and local health planning, financing, and local health systems
