#### Overall strategy


The World Health Organization (WHO) Regional Office for the Western Pacific (The Regional Office) encourages Member States to continue to suppress transmission of COVID-19 in order to avoid exceeding health system capacities and protect vulnerable populations. A risk-based approach using the following tools is recommended: COVID-19 vaccination, calibrated public health and social measures, strengthened health system capacity, early detection and targeted response and international border measures.

#### Key highlights

- New cases of COVID-19 were reported in 28 countries or areas in the Western Pacific Region (WPR) within the past seven days: American Samoa 1282, Australia 399 624, Brunei Darussalam 3840, Cambodia 260, China 29 191, Cook Islands 781, Fiji 67, French Polynesia 278, Guam 171, Japan 326 127, Kiribati 2, the Republic of Korea 1 778 697, Lao People's Democratic Republic (PDR) 15 431, Malaysia 101 068, Mongolia 636, Nauru 2, New Caledonia 90, New Zealand 86 330, Northern Mariana Islands 93, Palau 56, Papua New Guinea 116, the Philippines 2367, Samoa 1081, Singapore 34 325, Solomon Islands 1078, Tonga 1241, Vanuatu 1735 and Viet Nam 535 551.
- Three Western Pacific countries or areas that had previously reported cases have reported no new cases within the past seven days: Marshall Islands (504 days), Niue (7 days) and Wallis and Futuna (341 days). Four Pacific Island countries and areas have not reported a case to date: Micronesia (Federated States of), Pitcairn Islands, Tokelau and Tuvalu.



#### Weekly situation updates

- In the WPR, 31 countries and areas have reported COVID-19 cases since December 2019. Between 30 March to 5 April 2022, a total of 3 321 520 cases with 4986 deaths were reported, for a cumulative 48 287 614 cases with 214 588 deaths (proportion of fatal cases (PFC) 0.4%) as of 6 April 2022, 10:00 (GMT+8). Available data indicate that countries and areas in the WPR have identified imported cases and/or localized community transmission, while subnational areas in some WPR countries and areas have identified large-scale community transmission. Figure 1 shows the geographical distribution of cases reported in the last seven days. Updated information about transmission stage assessment (TSA) <sup>1</sup> in each Member State is available on the TSA map dashboard.
- Globally, 490 853 129 COVID-19 cases with 6 155 344 deaths have been reported in 230 countries or areas (PFC 1.3%) as of 5 April 2022 20:30 (CET). All regions reported decreasing trends in both the number of new weekly cases and deaths.

<sup>&</sup>lt;sup>1</sup> 0-No cases: no cases detected and no clear signals of transmission for at least 28 days (or two incubation periods); 1-Imported cases: cases reported in the past 28 days are imported or linked to importation within 3 generations, and there are no clear signals of local transmission; 2-Localized community transmission: cases reported in the past 28 days are localized and cannot be linked to importations, though most are linked to a cluster, and there are no clear signals of large-scale community transmission; 3-Large-scale community transmission: most cases reported in the past 28 days have no known link to a cluster and are spread across the area, and there are clear signals of increasing transmission and severe outcomes.





Figure 3. Epidemic curve of confirmed COVID-19 cases in countries or areas with the lowest number of cases, as of 6 April 2022 10:00 (GMT+8)

## New guidance

The Regional Office published the updated interim guidance on <u>Infection Prevention and Control during transfer and transport of patients with suspected or confirmed COVID-19</u>. This updated guidance includes the latest evidence and best practices including: personal protective equipment (PPE) for personnel involved in transfer; cleaning and disinfection after transfer; health-care waste management; and securing occupational health.

- The Regional Office published the updated interim guidance on <u>repurposing facilities for quarantine or isolation and management of mild COVID-19 cases</u>. In addition to updating Infection Prevention and Control (IPC) and other management recommendations based on new evidence and best practices, this guidance 1) expands to repurposing facilities for quarantine, 2) includes protection and provision of care for children, prevention and management of health care workers (HCW) infections, and 3) provides a monitoring and evaluation framework for quality improvement.
- WHO headquarters published a <u>strategic preparedness, readiness and response plan to end the global COVID-19 emergency in 2022</u>. This plan sets out a number of key strategic adjustments that, if implemented rapidly and consistently at national, regional, and global levels, will enable the world to end the acute phase of the pandemic.
- WHO headquarters published a global genomic surveillance strategy for pathogens with pandemic and
  epidemic potential, 2022–2032. The strategy provides a high-level unifying framework to leverage
  existing capacities, address barriers and strengthen the use of genomic surveillance in the detection,
  monitoring and response to public health threats.
